

Today the Committee on Small Business meets to discuss proposed reforms of the Small Business Administration s Small Business Investment Company Program. Recently our colleagues in the Senate marked up a bill that makes a number of substantive and necessary changes to the SBIC Program. We will be discussing this legislation along with other proposals in the course of this hearing. In previous hearings, this Committee has heard disturbing testimony regarding the status of the SBIC Program. To the SBA s credit, some of these problems have been remedied, as reflected by the quality of new applicants that are being attracted to the program. Also, we were pleased to hear of the return on the SBA s participating security investment through health care, with other distributions expected shortly. This is heartening, but we should not get carried away. That represents a \$260,000 return and repayment of principal, but there are still \$300 million of participating securities outstanding. This program has a long way yet to go and I hope to move it to an era of stability and prosperity. With that in mind, I must applaud some of the Senate s efforts. The most important reform in the Senate s bill is an increase in the capital requirements of the program to a minimum of...
